



**GENERAL SERVICE**

**Available:** To all customers located in the general service area of the District.

**Applicable:** To commercial schools, churches, public installations, and non-residential customers served through one point of delivery where no other specific schedule is provided. The maximum demand shall not exceed 100 kW. Also, applicable to public schools requiring transformer capacity in excess of 100 kVa where service is in conjunction with another meter which qualifies for the "H-LS" rate schedule. Schedule not available for crop irrigation service.

**Character of Service:** Alternating current, 60 cycles, single and three-phase, at any of the District's standard secondary voltages.

<b>Monthly Rates:</b>	<b>Summer</b>	<b>Winter</b>

Energy Charge per kWh	\$.0920	\$.0850

**Summer and Winter Seasons:** The summer rates shall apply to customer bills rendered between June 15 and October 15. The winter rates shall apply to customer bills rendered in the remaining months of the year.

**Production Cost Adjustment (PCA):** A production cost adjustment may be applied to all energy charges based on the production cost adjustment received from the District's power supplier adjusted for line losses.

**Determination of Maximum Demand:** The maximum demand for any billing period shall be the highest integrated kilowatt load during any thirty (30) minute period occurring in the billing period for which the determination is made.

**Annual Minimum:** The annual minimum under this rate shall be \$15.00 per installed kVA per year or \$252.00, whichever is greater. Customers not meeting their annual minimum shall be billed the appropriate amount upon disconnection of service or in December of each year.

**Municipal Lease Fee and/or Franchise Fee:** When the District has an agreement to lease the electric distribution facilities of a village, the District agrees to pay the village a percentage of the revenue derived from the customers served from the facilities owned by the community. The lease or franchise amount shall be added to each customer's monthly bill.

**Gross Revenue Tax Charge:** Customers residing within the corporate limits of an incorporated town or village shall be charged 5% of the monthly bill as a gross revenue tax.

**Late Charge:** Accounts where payments have not been received by the due date indicated on the bill shall be assessed a late payment charge as described in the District's "Customer Service Charges Rate Schedule".

**Nebraska State Sales Tax:** The Nebraska state sales tax shall be applied to all charges unless a valid tax exemption certificate is filed by the customer.

**Service Regulations:** Service under this rate schedule is subject to the District's Rules and Regulations.
